A.4.1.1 Executive Director

The Executive Director shall be authorized to carry out this portion of the budget including hiring and firing of staff without submitting matters previously authorized or individual appointments to the Executive Board except in the form of reports of action. Any action by the Executive Director shall be subject to review by the Executive Board upon request of any member of the Executive Board. A specialty in school library media is a required qualification for the ALA Executive Director. (Emphasis added for clarity of the report, will not be included in the Manual)
