**A Memorial Resolution Honoring Donald J. Sager**

Whereas the American Library Association (ALA) and the broader library community lost a valued member and leader on January 1, 2015, with the death of Donald J. Sager;

Whereas he gave more than 40 years of professional commitment to public libraries and inspired many librarians throughout his career;

Whereas he served as Commissioner of the Chicago Public Library (1978-1981), City Librarian and Director of the Milwaukee Public Library (1983-1991) as well as director of the public libraries in Kingston NY, Elyria OH, Mobile AL, Columbus OH, and Elmhurst IL;

Whereas he was a member of Board of Trustees of the Urban Libraries Council;

Whereas he won numerous awards, including the including being on the 30<sup>th</sup> Anniversary Freedom to Read Foundation Honor Roll;

Whereas he authored eight books and numerous publications, articles, reviews, and book chapters as well as serving as a contributing editor for *Public Libraries* for 10 years;

Whereas he also served the profession as president of Gossage Sager Associates, an executive recruitment firm specializing in library leadership positions as well as publisher and editor of Highsmith Press;

Whereas he served the American Library Association as president of the Public Library Association (1982-1983), Councilor-at-large, and member of both the Association for Library Trustees and Advocates (ALTA) and International Relations Round Table (IRRT);

Whereas he was the ALA Representative to the White House. Conference on Libraries and Information Science and chaired ALA Core Values Task Force;

Whereas he played an important role in the development of *Libraries: An American Value*, a set of principles adopted in 1999 by the American Library Association as a contract with the American public; and


